# 110/19 ENFORCEMENT

There were no new Enforcement Cases notified from EFDC.

# 111/19 PLANNING ITEMS OF CONCERN

**Russell Road** – Email advising that builders had started working on the site and have removed fencing and in doing so have damaged the pavement. It was then noted that the builder has subsequently written to nearby neighbours advising that once the works are finished they will put right any damage that has been caused.

**Buckhurst Hill Station** – it was asked who manages the CCTV cameras at the station, TFL manages these cameras.

**64 Princes Road** – it was advised that a tree outside this property has caused the pavement to crack quite significantly, but Highways has now placed an 'Uneven Surface' sign on the pavement.

**Princes Road** – It was reported that since the road has been resurfaced none of the speed humps have been replaced.

**Footpath Albert Road/Cascade Close** – It was reported of bags with polystyrene in have been dumped. This was previously reported to EFDC by the Office.

**Regency Lodge** – It was advised that the road that runs behind has not been cleaned/swept. Office to investigate.

**Queens Road** – It was reported that bags of rubbish are being placed by the railings opposite Churchill's Estate Agents. Office to investigate.

77 Queens Road – The Clerk advised the meeting that she has been made aware that the landlord has written to the occupiers of 75-77 Queens Road of plans that this site is going to be redeveloped and will include mews housing at the back. At this stage there is nothing to this effect on EFDC's website.
